IN 1989, CCA STAFF BEGAN REGULARLY STOCKING A SMALL OFFICE CLOSET WITH DONATED FOOD FOR CLIENTS. TODAY, CCA OPERATES ONE OF THE LARGEST CLIENT-CHOICE FOOD PANTRIES IN NORTH TEXAS, PROVIDING ESSENTIAL FOOD, PERSONAL HYGIENE AND HOUSEHOLD NEEDS TO MORE THAN 1,400 INDIVIDUALS EVERY WEEK. THE CCA FOOD PANTRY HAS BEEN VOTED THE #1 FOOD PANTRY IN NORTH TEXAS FOR THE LAST 5 YEARS. CCA'S CLIENT-CHOICE DISTRIBUTION MODEL EMPOWERS CLIENTS TO CHOOSE WHICH FOODS THEY WILL TAKE HOME, PROVIDING FLEXIBILITY AND PRESERVING THE DIGNITY OF THE CLIENT RECEIVING ASSISTANCE. WITH 40-60% OF THEIR FOOD NEEDS BEING PROVIDED BY CCA'S FOOD PANTRY, FAMILIES ARE ABLE TO RESERVE THEIR LIMITED HOUSEHOLD INCOME FOR OTHER ESSENTIALS
